Further President Cantonment Board also directed Sanitary Inspector to submit the requirement of fogging machine and sprays required for him on urgent basis for spraying in Cantonment since Dengue patients are recorded.

TREE PLANTATION NEAR YOG CEMENT FACTORY BY METAL MEN COMPANY

7. To consider and note the action taken by the Chief Executive Officer vide letter No. 137/CB/MSW/2019-20/1505 dated 29/07/2019 with respect to granting permission to plant saplings, trees at trenching ground Sy. No. 207/1 (part) towards East side facing the road near and around the old Octroi Naka, Ahmednagar Road, Cantonment Aurangabad to Metal-man Auto Pvt Ltd, B12, Waluj Aurangabad on their request letter dated 24/07/2019 to carry out the plantation drive.

After detailed discussion President Cantonment Board directed CEO to check with the Rules and provisions relating to Taxation policies and forward a detailed proposal to Principal Directorate, for their approval. Meanwhile all the residents of Cantonment to pay Rs 1200 + 10% of the outstanding dues towards new water connection. The calculation of ward no. 1 and ward no. 2 will be adjusted accordingly.

President Cantonment Board further informed Board that a meeting was arranged at Principal Directorate, Southern Command, in the year 2017 wherein PD, DE, directed that any amendment to the existing Taxation policies will be carried out only under the rules and provisions specified under the Cantonments Act, 2006. In accordance with the same, President Cantonment Board directed CEO to review Taxation policy and prepare a detailed report and submit the same in the ensuing Board Meeting for discussion. CEO may be granted 1 month of extension for preparation of the said report.

HANDING OVER OF THE SECURITY CUM OFFICE CABIN CONSTRUCTED AT WEEKLY MARKET TO TAX SECTION

However elected member ward no. 3 clarified that he has never submitted his decent earlier during the ordinary elections held in the year 2015._
