PUBLIC NOTICE

It is informed General Public that notified for all concerned that Govt. of India Ministry of Environment, Forest and Climate Change has amended above rules vide their notification published in Gazette of India Extra-ordinary vide G.S.R 571(E) dated 12th August,2021 read with plastic waste management rules 2016. Hence to implement the provision of above amended rules, the following prohibition as laid down under above rules shall be followed by all concerned in Aurangabad Cantonment area, as per provisions of Plastic Waste Management Rules, 2016 (As amended).

(i) The manufacture, import, stocking distribution, sale and use of carry bags, plastic sheets or like, or cover made of plastic sheet and multilayered packaging shall be subject to the following conditions,

a) Carry bags and plastic packaging shall either be in natural shade which is without any added pigments or made using only those pigments and colourants which are in conformity with Indian Standard IS 9833:1981 titled as "List of pigments and colourants for use in plastics in contact with foodstuffs, pharmaceuticals and drinking water" As amended from time to time.

(b) Carry bags made of recycled plastic or products made of recycled plastic hall is not used for storing, carrying, dispensing or packing ready to eat or drink food stuff.

(c) Carry bag made of virgin or recycled plastic, shall not be less than Seventy Five (75) microns in thickness with effect from the 30 September 2021 and One Hundred and twenty (120) microns in thickness with effect from the 31 December, 2022.

(d)Plastic sheet or lile, which is not an integral part of multilayered packaging and cover made of plastic sheet used for packaging, wrapping the commodity shall not be less than fifty microns in thickness expect where the thickness of such plastic sheets impair the functionality of the product;

(e) The manufacture shall not sell or provide or arrange plastic to be used as raw material to a producer, not having valid registration from the concerned State Pollution Control Boards or Pollution Control Committee.

(f) Sachets using plastic material shall not be used for storing, packing or selling gutkha, tobacco and pan masala;

(g) Recycling of plastic waste shall conform to the Indian Standard :IS14534:1998 titled as Guideline for recycling of plastics, as amended from time to time;

(h) The provision of thickness shall not be applicable to carry bags and commodities made up of compostable plastic. Carry bags and commodities made from compostable plastics shall conform to the Indian Standard: IS 17088:2008 titled as Specifications for Compostable Plastic, as amended from time to time. The manufactures or seller of compostable plastic carry bags or commodities or both shall obtain a certificate from the Central Pollution Control Board before marketing or selling; and

tie pro l(c arerial strange (i) Plastic material, in any form including Vinyl Acetate -Maleic Acid-Vinyl Chloride Copolymer, shall not be used in any package for packaging gutkha, pan masala and tobacco in all forms.

(j) Non-woven plastic carry bag shall not be less than 60 Gram per square meter (GSM) with effect from the 30 September, 2021.

(ii) The manufacture, import, stocking, distribution, sale and use of following single-use plastic, including polystyrene and expanded polystyrene, commodities shall be prohibited with effect from the 1st July, 2022-

(a) Ear buds with plastic sticks, plastic sticks for balloons, plastic flags, candy sticks, ice-cream sticks, polystyrene (Thermocol) for decoration;

(b) Plates, cups, glasses, cutlery such as forks, spoons, knives, straw, trays, wrapping or packing films around sweet boxes, invitation cards, and cigarette packets, plastic or PVC banners less than 100 micron, stirrers.

(iii) The provisions of (ii) (b) above shall not apply to commodities made of compostable plastic.

(iv) Any notification prohibiting the manufacture, import,, stocking, distribution, sale and use of carry bags, plastic sheets or like, or cover made of plastic sheets and multilayered packaging and single-use plastic, including polystyrene and expanded polystyrene, commodities issued after this notification, shall come into force after expiry of ten years, from the date of its publication.

The provisions of sec 289(5) of Cantonments Act, 2006 shall also be read together with above rules.

All other provisions existing under plastic waste management rules 2016 (as amended) are also applicable in Aurangabad Cantonment area mutatis mutandis.

Whoever in Cantonment manufacturers, supplies, carries or uses for packaging or any other purposes material of non-biodegradable nature including polythene bags shall be punished with fine which may extend to five thousand rupees or imprisonment which may extend to six months
