However it is also stated in above notification that whenever the applicable rate of Dearness Allowance is exceeded from 25% the rate of House Rent Allowance for the above classified cities will be given at the rate of 27%, 18% and 9% respectively. And if the Dearness Allowance is exceeded from 50% the rate of House Rent Allowance will be given at the rate of 30%, 20% and 10% respectively for the XYZ cities.

As on date the applicable rate of HRA is 18% for the Aurangabad Cantonment Board employees. The Financial implication works out of Rs.51,964/- i.e. increased amount per month in regular monthly pay bill. Necessary budget provision is already made in the budget estimates.

It is submitted that, the DGDE, Delhi Cantt. vide Letter No. 738/36/MISC/SVY/2022/Vol - I dated 04/05/2022, even No. dated 29/04/2022 had issued directions to carryout the internal polygon survey of the entire Cantonment (Cantt. - SVAMITVA) on the lines of "SVAMITVA SCHEME".

As per the directions / instructions issued in the V.C. held on 02/05/2022, 04/05/2022 and 06/05/2022 the boundaries of the Abadi areas of Cantonment are to be demarcated with the help of lime marking and thereafter Drone survey of the said marked boundaries is to be carried out.

In order to carryout the work within the stipulated timelines issued Drone agency M/s Pioneer Foundation Engineers Pvt. Ltd. were contacted which is finalized by the SOI through rate contract @ Rs. 21,240/- (including GST @ 18% ) for LOT 1 and Rs. 8,142/- (including GST @18%) for LOT 2.
