21. REMISSION FOR WEEKLY MARKET.

As per direction of the Collectorate, Disaster Management Aurangabad vide letter No. जा 2022/४८४९/आदेश /आपत्ति व्यवस्थापन/जिल्हाधिकारी.क. dated01.09.2022 has intimated that a lumpy skin disease has spread in Aurangabad district which is affecting the cattles and directed to keep the weekly market close. Accordingly this office vide letter no.9/MKTS/2022-23 dated 07.09.2022, directed the weekly market contractor to keep the animal Bazaar close for animal trading. At present the bazaar is closed for trading of animals till the further orders from the Collectorate, Aurangabad.

The weekly market contractor vide his applications dated 16/09/2022 and 23/09/2022 has requested that he is facing loss due to closing of animal market. As per the provisions of contract and he has requested for the following:

- a) To grant 75% remission in the monthly payment. Or
- b) To extend his term by three weeks or till the opening of animal market section.

Relevant documents are placed on table. Board to consider further course of action.

RESOLUTION:

The request of contractor to grant 75% remission in the monthly payment is rejected. (I) The Principal Directorate, Defence Estates, Southern Command, Pune vide letter No. 2922/DE/SC/L/Survey/Threat Matrix dated 16/09/2022 and DGDE, Delhi Cantt., Delhi vide letter No. 118/BGT/ADM/CH/Project/DE/2022 dated 28/09/2022 has instructed for submission of self – contained proposals for construction of Boundary wall / fence / boundary pillars of the vulnerable Class B-4 and C land pockets situated in Cantonment area in view to protect the Defence land from encroachment and trespassing.

As per the directions issued by the Directorate various zones based on Threat Matrix criteria and numerical values provided for assessment of the threat level are to be prepared and submitted to the PDDE, SC, Pune.

Accordingly the steps and instructions given were followed and following pockets of Class B4 and C land inside Cantonment area are detected which falls under Red Zone and needs to be protected by way of Boundary wall / fence / boundary pillars.

As per the directions the works will be executed through grant on submission of proposals. To protect such land pockets construction of boundary wall (for red zone pockets) and fence (for blue zone pockets) is proposed based on the information received from DEO, Pune. The detailed estimates duly vetted by the Sectional Engineer

of this office upto Rs. 50 Lakhs based on the standard estimates as per MES SSR 2020 as per provision of Section 116 (2) of CBAR 2020 is prepared as detailed below.
