#### GENERAL PARTICULARS/CONDITIONS ARE GIVEN BELOW:

1. Before starting auction each bidder will have to pay Auction Participation Fees of Rs.500/- through e-chawani portal which is **non refundable**.

It is presumed that the participant of auction have surveyed all the trees as mentioned above regarding the fruit yield and all other aspects pertaining to fruits and fruit collection and no claim/ discussion/argument shall be entertained by the undersigned during or after auction proceedings. Any query shall be addressed by this office until the previous day of the auction i.e. 05 /01/2023.
3. The Auction Participation Fees of the unsuccessful bidder will not be refunded back to bidders.
4. The successful bidder will have to deposit the bid amount within 24 hrs of the auction along with 18% GST additional, (if applicable) failing which next highest bidder may be considered. The successful bidder will have to deposit an addition amount of 10% of his bid offer as the security deposit.
5. The fruit of tamarind trees should be removed within 30 (thirty) days under the supervision of the Sanitary Inspector/Lands clerk, and the successful bidder shall be held responsible for the damages if any, during the removal of tamarind.

6. In case of failure, the same will be rectified at the risk and cost of successful bidder and the amount will be recovered from Security Deposit/bidder or else as recovery as per provisions of Cantonments Act, 2006.

In case, the successful bidder fails to remove the tamarinds fruits from the said tree within the stipulated time, the said fruits will become the property of the Cantonment Board and the Security Deposit of such bidder will be forfeited and he will have no further claim on such fruits whatsoever.
8. Any other taxes, if any leviable by the Govt. will have to be borne by the successful bidder.
9. The Chief Executive Officer reserves the rights to accept/reject the highest bid without assigning any reasons thereto.
10. Any other terms and conditions / instructions may be ascertained at the time of auction and should be complied with.
11. All the intending bidders are requested to remain present well before the above time and participate in the auction. The trees bearing fruits of tamarind to be put to auction may be seen by the intending bidder through the representative of this office during working hours until 05/01/2023.
