As per the contract agreement initiated and sanction of the competent authority the duration for the work was for a period of 02 years i.e. upto 08/01/2024. The CoW towers were installed on 03 Locations i.e. at Old Cantonment Board Office, Nagar Naka and Cantonment Board Office.

Now, the agency M/s Tower Vision India Pvt. Ltd. vide email dated 26/05/2023 had requested for extension in the term period for a further 10 years i.e. commencing from 08/01/2022 and valid till 08/01/2032.

As per Clause No. 4.3 of the contract agreement approved by the competent authority the same may be extended on mutual basis. The license fee will be revised by 10% after completion of every five year on a compounding basis. However, the renewal for further 10 years period shall be at the STR / Collectors rate prevailing at such time or the existing lease rent whichever is higher.

Thereafter, the application for attachment of movables of JD was filed in first proceeding and same is allowed. The matter is pending for execution of warrant.

As the JD is single therefore, a remaining matters are kept for the steps for attachment of immovable property and the same is under search. The next date of hearing is 14/03/2024.

The Hon'ble Court has issued notice to the M/s Saudagar Agencies in the execution matter bearing No. Reg Dkst/0002520/2023. The next date of hearing is 13/03/2024.

RESOLUTION:

11. Noted. The CEO, MS informed Board that the matter of execution for recovery of Rs. 16,79,944/- amount is filed in the court of law through Cantonment Legal Advisor as per directions of the Board.
