The Cantonment Board Aurangabad vide CBR No. 13 dated 29/02/2016 had allotted 03 No. of hotels inside Cantonment Weekly market premises on rent basis to Smt. Sakhrabai Jadhav, Shri. Sayyed Hafeez Sayyed

At present there is an outstanding amount of Rs. 98,176/- towards Smt. Sakhrabai Jadhav and Shri. Sayyed Hafeez Sayyed Kabir and an outstanding of Rs. 85,904/- towards Shri. Mazhar Khan Jabir Khan.

The above occupants have requested to deduct the rent amount during the Corona pandemic period as the weekly market was kept closed w.e.f 23.03.2020 to 02.07.2021 as per direction received from higher authorities during the pandemic period.

In recent efforts to collect outstanding arrears, these three shopkeepers were contacted again to pay their arrears. They stated that if given remission of Corona Pandemic period they are agreeing to pay the outstanding amount. The Board previously in similar instances have given such remissions to aggrieved parties.

In the  $10^{\text{th}} \& 13^{\text{th}}$  call called on 05/07/2024 & 20.09.2024 respectively one bidder participated and quoted MRP of Rs. 2020/- & Rs. 2300/- which was less than the MRP kept by the Board. Hence the said bid was rejected by this office.

In the 11<sup>th</sup> and 12<sup>th</sup> call no bidder participated in the bid. A time of three months have been lapsed and no bidders are participating in the auction due to high MRP.

Hence it is requested that, the MRP of the shop may be reduced so that bidders will participate in the auction and the further loss of revenue of Board due to the above will be avoided.

It is submitted that the Cantonment Board Office currently has two staff cars: a TATA Manza (MH20 CU 121) and a TATA SUMO. The staff car used by the Chief Executive Officer (CEO) of the Cantonment Board Aurangabad is a TATA Manza (MH20 CU 121), which is over a decade old, having been purchased in the year 2012-2013. This 'vehicle is outdated, affecting its performance and reliability, and needs extensive repairs, incurring costs of approximately Rs.50,000/- per month. Additionally, the TATA Manza is currently undergoing the Beyond Economic Repair (BER) process, indicating that it is unsuitable for long-distance travel and poses risks if continued in use.

Meanwhile, the BER process for TATA SUMO is also under process; the vehicle is stationary now and not in use.

The CEO frequently needs to visit the Principal Directorate Office in Pune for official duties, apart from her regular duties which requires her to be on round frequently. The lack of a reliable mode of transport is causing inconvenience and hampering official work.

To address these issues, there is a need to purchase new vehicle for which the approval of the Board is required. It is therefore kindly requested that sanction may be granted for the purchase of a new vehicle of latest model with updated features from the GEM portal / local market amounting to Rs. 16,00,000/- approx. (exclude. accessories and registration formalities).

The said vehicle will be procured as **per the availability of funds** with the Board and necessary Budget provision for the same will be done in the revised Budget for F.Y. 2025-26 (R).
