9. DEPOLYMENT OF 15 SECURITY GUARDS (EX SERVICEMEN) AT AURANGABAD CANTONMENT.

Cantonment Board Aurangabad proposes the deployment of 15 additional professional Ex. Serviceman security guards. These reinforcements are necessary to ensure the safety and protection of both personnel and property, particularly in high-priority.

Considering MESCO (Maharashtra Ex. Servicemen Corporation Ltd.) is already providing 05 professional Ex. Serviceman security guards and has a proven track record, it is proposed to engage MESCO for the supply of 15 additional security guards.

RESOLUTION:

9. Considered and approved. After detailed discussion Board informed CEO to carry out the tendering process with proper terms & conditions, and setting specific criteria's such as medical fitness etc. for deployment of Ex-serviceman security guards.

President Cantonment Board informed CEO to hire security guards with specific QR and also informed to include the clause of warning & termination of contract for providing nonprofessional Ex-serviceman security guards.

The Board also resolved that, new tender for hiring of security guards should be floated shortly and till the time security guards may be hired from MESCO.

10. REQUIREMENT OF ONE ADDITIONAL GARBAGE COLLECTION TIPPER FOR CIVIL AREA CTUS.

The Sanitation Section of the Cantonment Board Aurangabad is presently operating with only two 3-ton garbage collection tippers. Of these, one vehicle is exclusively assigned to the Station Cell for garbage collection within the Army area.

Due to the allocation of one tipper to the Station Cell, only a single vehicle remains to garbage collection from CTUs of civil area, which includes several CTUs spread across the cantonment limits.

To address these challenges and ensure seamless waste management operations, it is proposed to Hire one additional 3-ton tipper dedicated to garbage collection from CTUs in civil area. This additional vehicle will strengthen the sanitation infrastructure, improve coverage and frequency, and help maintain public health and cleanliness across.

Purchase of tipper will be done through process when funds are available. Till the time purchase is complete the board may consider hiring one tipper.

11. INITIATIVE FOR INCREASE IN GREEN COVER, BEAUTIFICATION AND IMPROVEMENT OF CANTONMENT AREA, AURANGABAD.

To consider and note the initiative taken up by the Chief Executive Officer, Cantonment Board Aurangabad to significantly increase the green cover, beautify, and improve various existing parks, green patches and vacant land parcels under the management of Board inside and outside civil area within the Cantonment Aurangabad.

In this regard Cantonment Board Aurangabad had carried out the following:

- a) Improvements in existing and identification of vacant land spots which can be beautified for creation of aesthetic look and improve the general scenario of Cantonment area and Entries of Cantonment. The list of spots is kept on the table.
- b) Constituted a dedicated gardening and horticulture team supervised and will work under the Engineering section. The said team consists of 10 persons (i.e. 4 existing Mali Cantt. employee + 5 persons semiskilled, 1 – Supervisor hired from the manpower agency M/s Balaji Blessing approved by the Board.
- c) To meet the requirement of availability of adequate water it is proposed to utilize the part of site located at the Cantonment Trenching Ground outside the civil area, bearing GLR Sy. No. 207/1, classified as Class 'C' land under the management of the Cantonment Board by way of well-dressing, removal of unwanted soil / moorum etc. for accumulation of rainwater for plantation and other purpose. The work will be carried out by Hiring of JCB and machinery through the approved contractor by the Board.

- d) Procurement of Garden equipment's and machineries, drip irrigation items etc. through Store section required for maintaining existing drip system and increasing drip irrigation in new green covered spaces listed above.

17. DRAFT BUILDING BYE LAWS IN RESPECT OF AURANGABAD CANTONMENT BOARD

Reference CBR No. 01 dated March 28th, 2025.

Board vide CBR No. 01 dated 28/03/2025 unanimously approved the draft Building byelaws of Aurangabad Cantonment Board for onward submission to the higher authorities for necessary vetting and approval by the Ministry of Defence. Board also authorized CEO to make any amendments, modulations as suggested / guided by the higher authorities. The same were forwarded to the competent authority vide this office letter No. 137/CB/B.B/2024-25/ dated April 1st, 2025.

The Principal Directorate, Southern Command, Pune vide letter No. 962/XIV/DE dated April 11th, 2025 raised few queries. As per the directions received following amendments were made in the draft building bye laws as detailed below:

- a) The Ground Coverage in Zone I (Inside civil area) is as per the definition of Ground coverage i.e. the quotient obtained in terms

of percentage by dividing the plinth areas of the Ground Floor by plot area. The value of which comes normally between 50% to 90% and for Zone II (Outside civil area and Bungalow area) the value of ground coverage should not exceed 50%. The same has been included in the draft building bye laws at Pg. No. 14 and 15 respectively.

- b) The Minimum plot size proposed in the draft building bye laws due to typographical error was mentioned 150 sqm. The same has been now corrected to 30 sqm in the draft building bye laws at Pg. No. 11.
- c) Few definitions which were deleted and modified are revised in the draft building bye laws according to the model draft bye laws forwarded by the competent authority. The same can be seen from Pg. No. 1 to 8.
- d) The additional points from (j) to (l) related to Non FSI spaces which were earlier included in the draft building bye laws have now been removed. Please see Pg. No. 28.
- e) In earlier draft building bye laws sent, the additional appendix viz. A – Application form, Appendix B Procedure for Submitting Application for Erection or Re-Erection of Building, Appendix – C etc. which were not mentioned in model building bye laws circulated by DGDE, has now been removed from the modified draft building bye laws of Cantonment Aurangabad.
