## Sub: Transfer of Old Grant properties - reg.

Reference is invited to the GGO 179 of 12.09.1836 and related GGOs governing the Old Grant properties in Cantonments.

- 2. The matter regarding seeking prior permission of Central Government for transfer of Old Grant properties, where the value of the building exceeds Rs. 5000/- has been examined in light of legal opinion of Ld. Attorney General for India.
- As per opinion of Ld AG, the paragraph 6(4) of the GGO 179 of 1836 is no longer applicable today, since the word 'native' to mean a native Indian as opposed to a British citizen/foreigner is no longer relevant and has ceased to have any effect. The said paragraph 6(4) is accordingly deemed as inoperative. Therefore, the cases seeking prior-permission for transfer of Old grant properties shall be entirely governed by paragraph 6(3) of GGO 179 of 1836, wherein Officer Commanding the Station is the competent authority.
- The proposals seeking permission for transfer of Old Grant Properties shall henceforth be processed as per the following procedure: -
  - The applications seeking prior permission for transfer of Old Grant (a) properties shall be preferred to the CEOs (for inside Civil areas) & DEOs (for outside Civil areas).
  - The applications shall be forwarded by the CEOs & DEOs alongwith the (b) recommendations of Cantonment Board & Defence Estate Office respectively, to the Station Commander within a period of 30 days.
  - While making recommendations, legal opinion of the Govt Counsel should (c) be obtained by the CEO/DEO on the draft Sale deed,

- (d) The Station Commander (Competent Authority) shall decide on the applications and convey his decision to the CEO or DEO, as the case may be, within a period of 30 days of receipt of proposal in his office. The CEO/DEO shall convey the decision to the applicant.
- (e) The Station Commander will be at liberty to seek advice from PDDE, the Con.mand on any specific land issue involved in the proposal.
- (f) The Appeal against the decision of Station Commander shall be before GoC-in-C. Appeal can be preferred to GoC-in-C within 30 days of the date of receipt of decision by the applicant.
- (g) Past cases of Sale of Old Grant properties without seeking prior permission of competent authority shall also be dealt in the manner indicated above.
- (h) Cases for condonation of other breach of Old Grant terms shall continue to be referred to the concerned competent authority for decision.
- (i) DGDE shall issue separate guidelines on the documents required to be submitted by the applicants and any other issue as deemed fit. The process shall subsequently be made online through a separate module on e-Chha vani portal.
